FMCSA - Drug and Alcohol Clearinghouse - IMPORTANT!!!

You must complete the registration process before you can respond to employer consent requests or access your driver record in the FMCSA Commercial Driver's License Drug and Alcohol Clearinghouse. Accessing the Clearinghouse requires the creation of an account with login.gov, a shared service that offers secure online access to participating government systems, including the Clearinghouse.

DOT Medical Exam Certification – IMPORTANT!!!

PLEASE be sure to allow enough time before your medical card expires to complete the exam and then CERTIFY with your licensing state. If your Med Card expires and the new one has not been certified your CDL will be immediately downgraded! This means that you are then driving on an invalid CDL and are subject to serious penalties, including vehicle impound.

- Keep 3 points of contact.
- Exercise care at heights to prevent slips, trips and falls.
