How is Your Driving? Feedback about driving behavior comes from a variety of sources including motor vehicle reports, accident reports and roadside violations to name a few. However, the driver should be the most influential monitor of his or her own driving. The driver has the most to lose if involved in a crash or for receiving multiple driving citations. And, regulated drivers' roadside violations can be reviewed by prospective employers, which could determine a driver's employability in the future. Only you can decide how many chances you are willing to take.

DOT MEDICAL CERTIFICATION

DOT Medical Exam Certification – IMPORTANT!!!

PLEASE be sure to allow enough time before your medical card expires to complete the exam and then CERTIFY with your licensing state. If your Med Card expires and the new one has not been certified your CDL will be immediately downgraded! This means that you are then driving on an invalid CDL and are subject to serious penalties, including vehicle impound.

After each US DOT physical examination, be sure your card has all the required entries, the entries are accurate and the information is legible. To protect the card, consider-sealing it in a plastic cover. CDL drivers must now certify their type of driving (e.g., interstate, intrastate, etc.) and submit a current medical examiner's certificate (card) to the state in which they are licensed.





SAFETY ZONE

FMCSA – Drug and Alcohol Clearinghouse – IMPORTANT!!!

You must complete the registration process before you can respond to employer consent requests or access your driver record in the FMCSA Commercial Driver's License Drug and Alcohol Clearinghouse.

Accessing the Clearinghouse requires the creation of an account with login.gov, a shared service that offers secure online access to participating government systems, including the Clearinghouse.

Compliance, Safety, Accountability/Safety Measurement System and you. Remember the violations charged to you may also affect your motor carrier's scores. Many shippers require that regulated fleets doing business with them meet certain violation score limitations and exceeding those limitations may potentially cause the loss of business. Likewise, a driver's score can also be impacted.

Is Your Paperwork in Order? Know and understand the information. Replace any missing information or forms; if unsure, contact a supervisor or responsible party. Do not hesitate to ask questions.
