#### **SAFETY ZONE**

**Interstate and Intrastate** – below you will find more information regarding the two different types of categories when obtaining a Medical Card. More times than not, we run into these issues which must be resolved before you can get back on the road with us.

<u>Category 1 – (NI) – Non-excepted Interstate</u> - I will operate a commercial motor vehicle both in and outside the boundaries of your state. Select this category only if you are 21 years of age or older and do not have or require a "K" or "W" restriction on your Commercial Driver's License.

<u>Category 2 – (NA) – Non-excepted Intrastate</u> - I will operate a commercial motor vehicle only within the boundaries of your state. Select this category if you are:

- Under 21 years of age or
- Maintain or require a medical waiver "W" restriction on your Commercial Driver's License or Choose to add or maintain an intrastateonly "K" restriction on your Commercial Driver's License.

## More than 1,700 CMV violations found during CVSA's Inspection Initiative

From June 13-17, commercial motor vehicle inspectors examined 6,204 vehicles transporting hazardous materials/dangerous goods.

The total number of violations was 1,774, according to a news release. Inspectors discovered some of the following violations:

- 408 shipping papers violations.
- 79 other safety marks violations.
- 168 loading and securement violations.

## According to FMCSA's data for last calendar year (as of Aug. 26, 2022), the top five hazmat violations in the U.S. were:

- 1. Package not secure in vehicle.
- 2. No copy of USDOT HM registration number.
- 3. No or improper shipping papers (carrier).
- 4. Shipping paper accessibility.
- 5. Vehicle not placarded as required.

#### **Log Falsification Violations**

Log falsification has plagued the industry for decades. In fact, it was the primary driving force behind the ELD mandate. Unfortunately, ELDs haven't completely eradicated that issue. Carries and drivers still find ways to sidestep the HOS rules by manipulating their electronic logs. During the roadside inspections in 2022, this was the third most frequent violation.
