Tax Season!

W2's have been mailed, they are electronically available now so if you are in need of a copy, please let us know.

It is important that you have all the information you need to file your 2022 tax returns.

How to File - Many people elect to file their tax returns electronically. This can be done in a variety of ways, including tax-preparation software, like Turbo Tax, consulting a tax return professional or using the IRS' Free File software, if you qualify.

Forms to Include:

- A copy of your W-2 for each of your employers over the last year.
- A copy of Form W-2C (a corrected W-2 form), if needed.
- A copy of Form 1095C for healthcare.

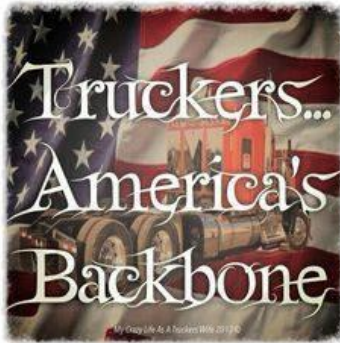

Spring forward! Daylight saving time 2023 in Pennsylvania will begin at 2 AM on Sunday March 12th, 2023. Don't forget to change your clocks!

*****International Roadcheck!***** The Commercial Vehicle Safety Alliance's (CVSA) International Roadcheck will take place May 16-18 2023. More information to follow as this approaches. For 72 consecutive hours, truck and bus inspectors throughout North America will conduct roadside safety inspections. International Roadcheck is the largest targeted enforcement program on commercial motor vehicles in the world, with nearly 15 trucks or buses inspected, on average, every minute.

Make it a habit to ensure your card is with you at all times when driving as required by the Federal Motor Carriers Safety Regulations. Not having a physical card during a roadside inspection will result in a violation, and the points can affect the US DOT CSA rating for you and the motor carrier.

Federal cell phone restrictions. All regulated commercial vehicle drivers must follow the requirements regarding distracted driving, e.g., using cell phones and other mobile communication devices. There are driver penalties up to \$2,750 for the first offense and for each offense thereafter. CDL privileges could be suspended, and employers could be fined up to \$11,000. **Stay Alert!**
